The Vendor/Exhibitor agrees:

I will adhere to the space boundaries marked out by BCSMP and will not alter these boundaries in any way.

I will not have open or contained flames in my exhibit and will use only fireproof table covers.

I will keep all boxes out of sight or covered in my booth.

I will not nail, tape, or modify the walls or floors of the building. I may bring my own backdrop for this use.

I will be courteous and considerate to the other antique show exhibitors. I will not block the driveways with my vehicle when setting up and tearing down my exhibit. I will unload my vehicle in a timely manner and will not build my booth until I am finished unloading. I will remove my merchandise from the exhibit hall aisles in a timely manner and will keep the designated aisles clear of merchandise during the show.

I will not start packing-out on Sunday until BCSMP announces that the show is officially closed. I will inform the Posse if there is an emergency or valid reason for my leaving before the show is over.

I will wear my exhibitor badge at all times during the show. **My badge will be clearly visible when I enter the exhibit hall so that I can be easily identified. I will use the designated door for entering and leaving.** I agree to return my badge to the Posse at the end of the show.

I will be allowed access to the exhibit hall beginning at 8:00 a.m. each show day.

I agree not to open any side door without a BCSMP or designated person present. (Personnel designated by the BCSMP will be posted at the main and kitchen entrances and will provide security throughout the building at all times during the course of the show).

I understand that the BCSMP is not responsible for unforeseen events, such as but not limited to fire, flood, earthquake, theft, or breakage. I agree not to hold BCSMP liable for damages to merchandise that may occur during any activity associated with this event. (Security will be provided by the BCSMP).

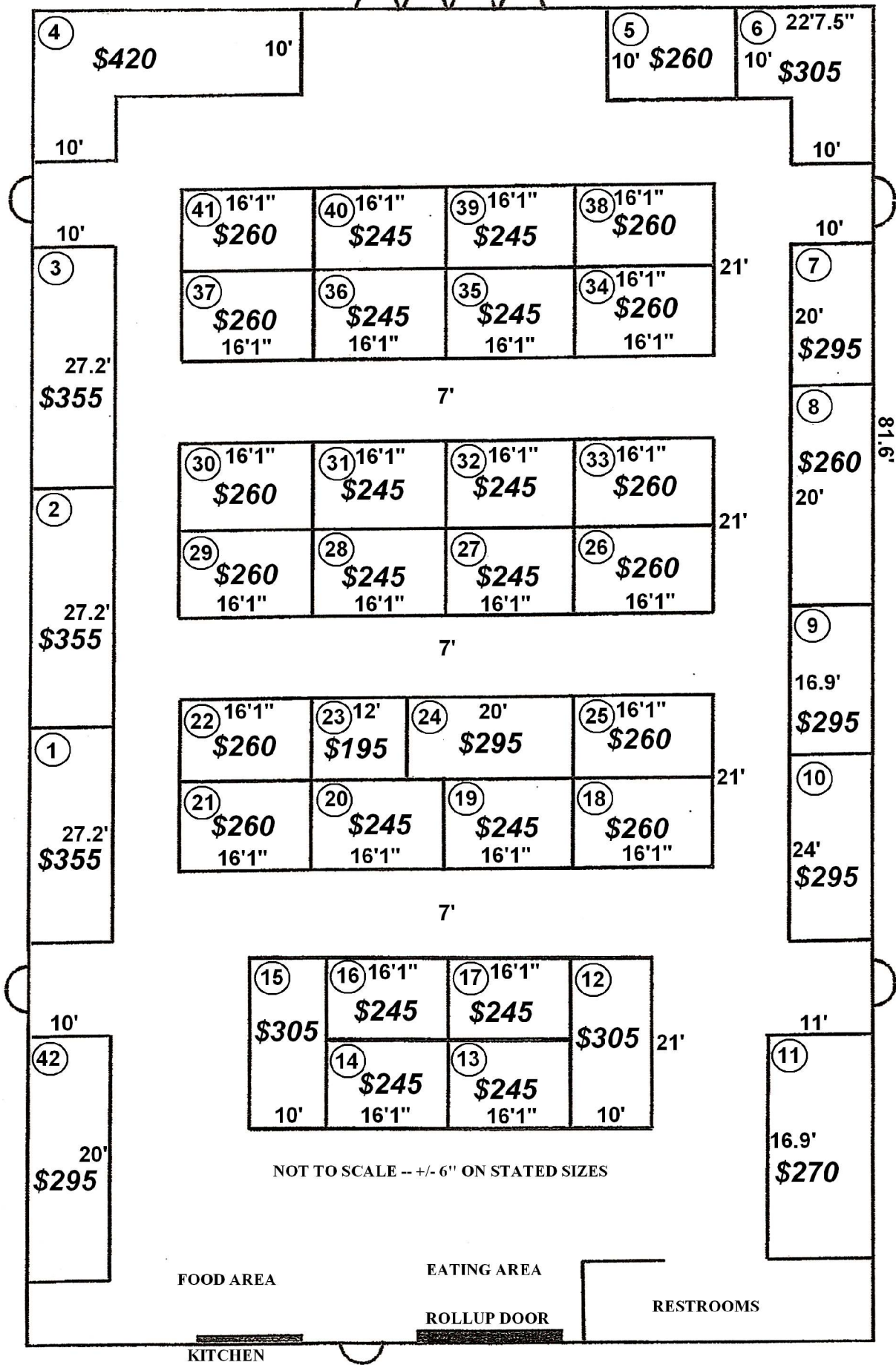
